Membership Category Playing Rights

Junior Members

For the purpose of these conditions, a Junior Member will cease to be a Junior Member at the time he/she makes application for transfer to another category of membership and will be ineligible to compete in club junior events on attaining the age of 21 and State Junior events upon turning 18.

Junior Members competitions are held on Sunday mornings between 11am - 11.28am. Junior Members are a vital part of our Club and will be given every encouragement by the Match Committee.

Junior Members may be granted privileges to play in senior competitions under the following conditions:-

Junior Playing Rights (12 years and over)

A. Handicaps of 12 or less

- i. Junior with active handicaps of 12 or less may apply to the Captain for permission to play in either the Saturday am or pm competitions.
- ii. Those given permission wishing to play in the pm competition must play in the earliest time slot available, no later than 11.56am.
- iii. May play social golf mid-week under the control of the Pro Shop Staff.
- iv. May play in the mid week competition on Wednesdays
- v. Expected to play in the Junior Sunday Competition between 11 am and 11.28am to assist the development of higher handicapped juniors.

B. Handicaps 13 to 27

- i. Permitted to play in the mid-week Wednesday competitions, but must hit off prior to 8.45 on Wednesdays.
- ii. May play social golf mid-week under the strict control of the Pro Shop staff.
- iii. Play Sundays, only in the Junior Competition, hitting off between 11 am and 11.28am.
- iv. All players must use the time sheet on Sundays (40 spots only available)

ONLY JUNIOR MEMBERS WITH HANDICAPS ARE ELIGIBLE TO ENTER JUNIOR COMPETITIONS

Playing Rights for Membership Applicants

Applicants for Membership DO NOT become a member of the Club until approved by the Membership Committee, which meets on the third Tuesday of each month and then endorsed by the Board of Management, which meets on the fourth Tuesday of each month. Pro-rata membership subscriptions are charged from the 1st day of the month following the Board of Management meeting.

Once the Applicant has submitted the complete nomination form, accompanied by the Entrance Fee, they may be invited to play as the guest of a member, preferably either the proposer or the seconder. They are not permitted to enter any competition or play on competition days unless they are a current member of an affiliated Club and hold a current AGU or WALGU handicap and then only play in designated competitions approved by the Club Captain. Whilst awaiting approval, an applicant may – in order to obtain a recognised handicap, complete up to five full rounds of golf but not in any competition play. Applicants who play five games and acquire a handicap still cannot enter or play in competition play until the 1st day of the month following the Board of Management meeting.
