**Membership Category Playing Rights
Provisional**

Provisional members shall be persons who are elected as a Provisional Member in terms of these Rules and shall have full privileges of the Clubhouse. It must be noted that Thursday is the Ladies Competition Day with Tees closed until 11.30am.

Six Day

Six Day members shall be persons who are elected as a Six Day Member in terms of these Rules and shall have full privileges of the Clubhouse and have use of the course and playing facilities from Monday – Friday and Sundays or as otherwise determined from time to time by the Board, taking into regard the availability of playing times. It must be noted that Thursday is the Ladies Competition Day with both tees closed between 7.45am – 8.45am. Members may hit off prior to or after these times.

Midweek

Mid-week members shall be persons who are elected as a Midweek member in terms of these Rules and shall have full privileges of the Clubhouse and have use of the course and playing facilities from Monday – Friday or as otherwise determined from time to time by the Board, taking into regard the availability of playing times. It must be noted that Thursday is the Ladies Competition Day with both tees closed between 7.45am – 8.45am. Members may hit off prior to or after these times.

Country A (Full playing rights)

Country A members shall be persons who are elected as a Country A member in terms of these Rules. A Country A member is a member whose usual place of abode is more than 150km distance from the Club and is elected by the Board as a Country A member during such time as a member resides beyond such a distance. Subject to playing rights as determined by the Board, a Country A member has the same playing rights as a Full member, but shall not be entitled to use the course on more than fifteen (15) occasions in any financial year. If the Country A member ceases to reside beyond such a distance as determined above, the member may apply for a transfer to another category of the membership in terms of these rules.

Country B (Six Day playing rights)

Country B members shall be persons who are elected as a Country B member in terms of these Rules. A Country B member is a member whose usual place of abode is more than 150km distance from the Club and is elected by the Board as a Country B member during such time as a member resides beyond such a distance. Subject to playing rights as determined by the Board, a Country B member has the same playing rights as a Six Day member, but shall not be entitled to use the course on more than fifteen occasions in any financial year. If the Country B member ceases to reside beyond such a distance as determined above, the member may apply for a transfer to another category of the membership in terms of these rules.

Fly In Fly Out (Full playing rights)

Fly In, Fly Out members shall be persons who are elected as a Provisional Member in terms of these Rules and shall have full privileges of the Clubhouse. It must be noted that Thursday is the Ladies Competition Day with Tees closed until 11.30am. Fly In, Fly Out members have the same rights as Provisional members but at a discounted rate therefore a letter must be received from their employer along with the application form. A letter from their employer will be required every six months as proof of continued employment in a Fly In, Fly Out capacity.
